# 1. Bids to Construct Water Distribution System at Duck Creek: Loseke reviewed the bids received:

Hilske explained that this is considered a transient public water supply, so it must meet certain standards.

2. Revised OPPD Proposal to Provide Power for Duck Creek Rec Area: Loseke explained that OPPD had revised their proposal to bring power into the park after it was approved last month. Hilske explained that the new proposal would add another transformer and, ultimately, reduce the cost for the interior electrical system. It also included another pole to provide power for an overhead light at the boat ramp, which is required by the Game & Parks grant. There was some discussion on whether there were other options available. Stukenholtz suggested that if there was error, we should negotiate the revision with OPPD.

Loseke moved, seconded by Gerweck, to approve the revised proposal from OPPD to provide power for the Duck Creek Recreation Area at the new rate of \$54,715. After further discussion, motion carried.

Loseke moved, seconded by Siske, to nominate Ben and Paula Sue Steffen from Humboldt for the 2017 NARD Soil Stewardship Conservation Award. Gigstad explained this award, which is new this year. Kuhl provided some background on the nominees, who were submitted by Mike McDonald. Motion carried.

Supporting NARD Plan to Fund the 2020 North American Envirothon in Lincoln: Hilske explained the anticipated funds required to put on this event and the breakdown of funds requested from each NRD over a three-year period. It is hoped that enough donations and grants might be obtained to alleviate the requirement for a payment in the third year. Our District's contribution is set at \$4,245 per year for three years. Some discussion centered on where additional funds might come from.

Niedfeldt moved, seconded by Keithley, to approve a three-year commitment to the 2020 North American Envirothon in Nebraska with a maximum of \$4,245 per year. After further discussion, motion carried.
