April 11, 2019 Nemaha Natural Resources District Regular Meeting Tecumseh, Nebraska

1. CALL TO ORDER/ROLL CALL/MOMENT OF SILENCE

Following the Pledge of Allegiance and a moment of silence, Niedfeldt announced that the Open Meetings Act was posted at the back of the room.

2. **PROOF OF PUBLICATION**

Proof of Publication was presented and is on file.

3. EXCUSED ABSENCES

Siske moved, seconded by Gerweck, to approve the excused absences requested by Dave Guhde, Doug Iske, Bob Lassen, Mike Speece, and Dan Stukenholtz. Motion carried on consent agenda.

4. **OPEN FORUMS**

NRD directors and staff introduced themselves. Niedfeldt announced that guests have the option to introduce themselves at this time, and by doing so their name would be included as part of the meeting minutes.

5. MINUTES

<u>Siske moved, seconded by Gigstad, to approve the minutes as presented.</u> <u>Motion carried on consent agenda.</u>

6. TREASURER'S REPORT

<u>Sugden moved, seconded by Siske, to approve the Treasurer's Report as submitted.</u>
Motion carried on consent agenda.

7. STAFF REPORTS

Hilske reviewed his written report and provided a PowerPoint presentation of recent flood damage in the District. Nelson reviewed his written report. Mike McDonald briefly commented on the Washington, DC, trip.

8. AGENCY/ASSOCIATION REPORTS

A. Natural Resources Conservation Service

No report. Hilske noted that NRCS has some emergency funds available for repairs on public land.

B. Five Rivers RC&D

Sugden reported they are still looking for new members. He reviewed the recent grants they have received.

C. Nebraska Association of Resources Districts

Gigstad reviewed the proposed budget detailing both revenue sources and expenditures.

D. Nebraska Natural Resources Commission

McDonald stated they had not had a meeting since last month.

9. Presentation on Development Project for Upper Little Nemaha 17

Don Blankenau explained the plans for the structure by Mike Hayes, the landowner, and how it would affect the structure. He has drained the lake to allow removal of sediment; and he wants to increase the size of the pool, which will require a permit from the State. He wants to add a cabin on the dam itself, which will also require DNR approval. Hilske explained that anything that is done must fit within the requirements of our easement. We won't know if it does until a final proposal outlining their plans is provided to the District. A question of setting a precedence for other structures was also a concern brought up by the board. Hayes asked for input or questions from the board on his proposal as they proceed.

10. STANDING COMMITTEES

A. Programs & Projects Committee

1. Bids to Rehab Upper Big Nemaha 25-C: Bids received were as follows:

Nelson reviewed the bids and explained that our original agreement with NRCS was for a \$2.2 million project. Therefore, NRCS would have to provide an additional \$131,000, and the NRD would contribute an additional \$71,000. In discussions with NRCS it appears they would be willing to increase their portion of the cost.

Gerweck moved, seconded by Siske, to approve the low bid of \$2,498,454.70 from Dixon Construction for the rehabilitation of Upper Big Nemaha 25-C contingent upon NRCS agreeing to provide the additional \$131,000 for the project. Nelson also explained that some contractors that might have bid were now tasked with flood related work this year. After further discussion, motion carried.

<u>Sugden moved, seconded by Gigstad, to approve well permits N716 and N717.</u> Wingert reviewed each application's details. After some discussion, <u>motion carried</u>.

3. Irrigation Transfer Permit Request: Wingert explained the request from Ron Meyer and that his request meets two out of the three requirements for approval: (1) the land is contiguous; (2) the maximum number of acres does not exceed what the supply well has historically irrigated; (3) the score for the well, however, is now less than the required 201 points. He explained that the score for the original, approved well was based on the test hole at that time. However, our rules require the score for the well

now be based on the well log, which resulted in some minor differences. This is something the committee has been considering changing in our rules updates. Therefore, the committee suggested the landowner wait until the board decides whether to change this rule as part of the update process. Meyer indicated he would agree to waiting for a decision.

4. E-Energy Adams Letter of Support for REAP Grant: Wingert explained the grant was to help fund an expansion project. He provided maps showing the area and nearby observation well readings. They are requesting a letter of support from the NRD since their project will increase their annual groundwater withdrawal.

Sugden moved, seconded by Siske, to send a letter of support for the REAP grant application for E Energy Adams. Motion carried.

C. Executive Committee

- 1. Rules & Fees for Persons Staying at Duck Creek due to Flooding: Hilske reviewed the activities to date to allow those displaced due to flooding to stay at Duck Creek free of charge. The committee discussed whether to begin charging for camping and park permits as well as how long those folks should be allowed to stay. It was consensus that they should begin paying for their camping and park permits beginning on Monday, April 15. They will be allowed to stay through the May 9 board meeting when the board will again review this situation.
- **2.** *Update on Duck Sediment Basin Land Rights:* McDonald reported that staff is working on a proposal based upon the assessor's values.
- 3. New Contract with Schulz and Associates to Perform Annual District Audit: McDonald reported that this firm, which has prepared our audit for the past nine years, submitted a proposal for another three years at the same rate of \$6,600 for the base audit and \$1,500 for a single (federal) audit, if needed, per year.

McDonald moved, seconded by Siske, to approve the proposal from Schulz and Associates to prepare the District audit for fiscal years 2019, 2020, and 2021 at an annual rate of \$6,600 for the base audit and \$1,500 for single audit, if required. Motion carried.
