Sugden reported that the Weed Management Board will host a cost-share conference on the 25<sup>th</sup> in Syracuse. They are also in the midst of household hazardous waste collections.

Gigstad encouraged directors to attend the annual conference in Kearney in September. He also reported on the NACD meeting he had attended in Iowa and the awards they gave out there.

## 9. STANDING COMMITTEES

## A. Programs & Projects Committee

- 1. Review/Action on Well Permit Applications: None received.
- 2. Environmental Trust Grant to Install Monitoring Wells: Hilske explained the purpose of the grant. Jon Mohr talked about the Auburn part of this project. Gigstad asked if we do any stream gauging now and Wingert responded that we have done some in the past but not a lot and that there is a USGS stream gauge nearby.

Beethe moved, seconded by Sugden, to approve the resolution to apply for Nebraska Environmental Trust Funds for installation of monitoring wells. Motion carried.

3. PL566 Funding to Construct Sediment Control Structure South of Duck Creek: Nelson reviewed the proposed project and funding. He estimated with engineering, land rights, and construction a total cost of around \$320,000, of which \$40,000 would be our share. We could know by the end of September if this is approved.

Gerweck moved, seconded by Sugden, to approve the application for PL566 funding to construct a sediment basin on Duck Creek. Motion carried.

4. Irrigation Runoff Complaint Filed Against Jared Janssen: Wingert explained that Janssen's neighbor called complaining about runoff from flood irrigation. He checked LIDAR data which indicated this is a natural flow of water. Since this is flooding an access road for the neighbor, Janssen offered to do something to improve the situation which might include adding rock to the road. No action.

1. **Delegate & Alternate to NARD Annual Conference:** Hodges and Gigstad offered to be the delegate and alternate.

2. Temporary Construction Agreement & Revised Perpetual Easement for Upper Big Nemaha 25-C: Niedfeldt explained the difference in the two documents. Hilske went over the changes which included the reason for splitting it into to documents, which had to do with requirements for a survey by the County Register of Deeds. We are waiting for the owners to sign the agreement.

Niedfeldt moved, seconded by Gigstad, to approve the temporary construction agreement and revised perpetual easement for Upper Big Nemaha 25-C. Motion carried.

Seeding Proposal for Duck Creek: Niedfeldt reported that we have a bid from Nebraska Hydroseeding to smooth and reseed some areas at Duck Creek where grass seeding was not successful earlier in the year. The bid totaled \$14,467.20. Hilske explained that weather played a large part in the problems with the original seeding.

Niedfeldt moved, seconded by Siske, to accept the proposal from Nebraska Hydroseeding to reseed areas at Duck Creek at a cost of \$14,467.20. Beethe asked if there was a warranty on the seeding; Hilske replied that he would check into that. After further discussion, motion carried.

This would still leave about \$40,000 that could be cut from the tax request. With this proposal the levy would be at or slightly below three cents.
