**8. STANDING COMMITTEES****A. PROGRAMS & PROJECTS COMMITTEE****1. *Update on Groundwater Quantity Management Rules & Regulations Revisions:***

Wingert reported that he had provided the first draft of the rules. He reviewed the proposed timeline for adoption and asked for board input in the next few weeks.

- 1. *Request from Conservation Nebraska for Test Your Well Partnership:*** Ensor explained the program which provides free water test kits to private well owners. There would be no cost to the District, but they would ask for assistance in contacting those owners within the District.
