7. STAFF REPORTS

Hauschild reported on the recent benefits committee meeting, efforts to contact our congressional delegation for help finding funds for watershed repairs, a Nebraska Legacy meeting he attended, status of the drill rig in the spillway at South Branch 34, and the upcoming radio show. He directed attention to a banner on the wall detailing flooding history and subsequent efforts in the Upper Big Nemaha watershed. Hauschild also reviewed the open house held in Adams regarding the UBN 7-A structure.

Burgert gave a brief report on the activities within the NRCS offices.

B. Nebraska Association of Resources Districts

Gigstad reported that the insurance program is in good financial shape and that the plan administrator would be changing for the 125-plan part of the program. They are doing a year-long study of our third part administrator. They are also considering a change to the contribution percentages for the retirement program to bring it up to industry standards. The NARD board discussed the Farm Bureau stance on eliminating property tax funding.

- 4. Presentation from Otoe County RWD: Scott Bruns, manager of the Otoe County Rural Water District #3, addressed the board regarding the water shortage concerns experienced this summer. He provided graphs that compared water levels in their wells during various time periods, especially in August each year. There was discussion about the need for education to increase water use efficiency and the grant application for nozzle replacement.
- 5. *Update on SWCP Extensions:* Kuhl reported that the three projects receiving extensions were either completed or near completion. Therefore, no further action was required.
