1. Review NARD Resolution & Provide Direction for Delegates: Hauschild explained that the resolution appears to ask NRDs to play a role in determining sustainable farming and ranching practices. Moss stated the committee did not feel this was the NRD's responsibility; and, therefore, the committee recommended against supporting the resolution.

Moss moved, seconded by Stukenholtz, to oppose support of the NARD Resolution 2022-1. Motion carried.

- 2. Proposals for Engineering on Upper Big Nemaha 7-A: Moss stated four proposals were received ranging in cost from \$4,500 to \$15,000 for investigating possible seepage at this structure. The \$4,500 proposal was from FYRA Engineering; and since it was below \$5,000, the committee authorized the manager to proceed with offering the contract to FYRA. Hauschild explained the project and need for the engineering study.
- 8. ACTION TO APPROVE FY23 BUDGET & RESOLUTION SETTING THE PROPERTY TAX Hauschild reviewed the final budget figures adding that some additional cuts were needed to keep the levy at the same rate as last year.

Sugden moved, seconded by Gerweck, to approve the FY23 budget as presented and the resolution setting the property tax request at \$2,333,603.99 resulting in a levy of \$0.029532. Beethe asked about a small difference in tax amounts on the valuation spreadsheet, which was a result of rounding differences. Motion carried.
