INVITATION FOR WRITTEN FORMAL QUOTES

Nemaha Natural Resources District Steamboat Trace Trail Mechanical Tree Removal

Written formal quotes, based on lump sum for the work described herein will be received until **3:00 p.m., Tuesday, March 12, 2024**, at the Nemaha Natural Resources District Office, 62161 Highway 136, Tecumseh, NE.

Prospective contractors may assemble at the Peru Trailhead 10:00 a.m., Monday, February 26, 2024, for a group contractor site showing of the work. The trailhead is located on 5th Street, approximately 3 blocks north of downtown Peru, Nebraska. In case of inclement weather, please contact the NRD office (402) 335-3325 for information.

The proposal shall be made on forms furnished by the NRD.

1. **DESCRIPTION OF WORK:** Tree removal of approximately 75 trees on the right of way of Steamboat Trace Trail, in Peru, NE, shown on the attached maps with quote schedule. Work consists of trees being taken down by excavator or cutting, stump removal by grubbing or grinding, and hauling trees/debris to City of Peru tree dump. The City of Peru has granted the NRD written permission to dispose material removed from site to tree dump for disposal. Trees will be required to be de-limbed prior to April 15, 2024, due to the April 15th federal bird nesting date guidelines. Stump removal and remaining clean-up needs to be completed by Tuesday, April 30, 2024.

The work shall be commenced after successful contractor's quote is formally reviewed and accepted at the NRD Board meeting on March 14, 2024, and given Notice of Award and to Proceed by the NRD on/after March 15, 2024.
