8. AGENCY/ASSOCIATION REPORTS

A. Natural Resources Conservation Service

Reichmuth reported they are trying to obligate last minute funding before the end of their fiscal year. They also may have some new staffing in place soon.

B. Five Rivers RC&D

Sugden reported on a workshop held in Syracuse in August and the household hazardous waste collections. He stated they could use more help at the upcoming collections in Tecumseh and Pawnee City.

C. Nebraska Association of Resources Districts

No report. The annual conference will be held September 23-24 in Kearney.

D. Nebraska Natural Resources Commission

McDonald discussed one of the NARD's resolutions that was about membership on the Commission.

9. STANDING COMMITTEES

A. Programs & Projects Committee

- 1. Well Permit Applications: No applications were received.
- 2. Update on Groundwater Rules, Projects, & Other Programs: Wingert reported that the rules are essentially done, and he highlighted some of the changes. He delineated out the Missouri River and Big Nemaha River. McDonald asked why chemigation and water quality are not being addressed and how quantity and quality rules interface. Wingert explained that this report only addresses quantity and that quality is addressed separately. There was also discussion about whether there should be more rules for Phase III areas. Wingert planned to send out the completed rules for directors to review soon.

3. Extend the 300-Point Minimum Score Requirement for Well Permits in Eastern Richardson County:

Gerweck moved, seconded by Sugden, to extend the 300-point minimum score for well permits in eastern Richardson County for one year to September 30, 2020. Wingert reviewed how some of the mapping will affect this area to be included once the rules are approved. Motion carried.

B. Operations & Education Committee

1. Request from Village of Adams for Letter of Support for Grant to Upgrade Park: Hodges explained the project that the Village is planning and their request for support. Kuhl added that the letter did not provide for any financial or technical obligation on the District's part. Hilske explained that the Village may apply for assistance from the District in the future for components of the project.

1. Review/Establish Positions on NARD Annual Conference Resolutions: Hilske reviewed each of the two resolutions. McDonald reported that the committee supported the resolution which would require members of the Natural Resources Commission which are appointed by the Governor to be Nebraska residents. The committee suggested the voting delegates obtain more information at the conference on the second resolution which addressed extending bonding authority to all NRDs. The delegation would then decide what position to take.

10. **FY2020 BUDGET**

Hilske reviewed the budget and some of the changes required to balance the final budget. He stated the only other place that changes could have been made would have been within the SWCP allocation but that he did not change that amount since the board had voted to increase it last month. He added that no comments had been received at the public hearing held prior to the meeting.
